## CLASSIFICATION - CONFORMATION

The following classes will be provided, divided by sex.

### REGULAR CLASSES

**JUNIOR PUPPY** – Dogs 6 months of age and under 9 months of age on the day of the show.

**SENIOR PUPPY** – Dogs 9 months of age and under 12 months of age on the day of the show.

**12-18 MONTH CLASS** – Dogs 12 months of age and under 18 months of age on the day of the show.

**CANADIAN BRED** - Dogs born in Canada. Champions of any country are excluded.

**BRED BY EXHIBITOR** - Dogs owned and handled in the ring by the breeder. The handler must be the owner/co-owner and breeder/co-breeder of the dog.

**OPEN CLASS** - All dogs.

**SPECIALS ONLY** – Dogs which have a recorded CKC registration, Event Registration Number (ERN) or Miscellaneous Certification Number (MCN) and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

### **NON-REGULAR CLASSES**

**BABY PUPPY** – Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, and Best Baby Puppy in Show.

**BRACE CLASS** - This class shall be for 2 dogs of the same breed (not necessarily of the same sex).

**TEAM CLASS** – The requirements for this class are the same as those for the Brace class except that 4 dogs shall be entered.

**ALTERED DOG** - Eligibility for the altered classes shall be limited to dogs over 6 months of age which have been spayed or neutered by veterinary procedure. Points may not be carried from the regular competition judging to the Altered class judging.

**EXHIBITION ONLY** - Dogs entered in this class may not compete in the Regular class but may enter and compete in Non-Regular classes and/or Parades if provided for in the premium list.

### **CLASSIFICATION - RALLY OBEDIENCE**

**RALLY NOVICE A** - Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one trial.

**RALLY NOVICE B** - Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**RALLY INTERMEDIATE** – The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes. This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**RALLY ADVANCED A** - This class shall be for dogs that have earned the R. N. title but have not earned the R.A. title or any CKC Novice Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**RALLY ADVANCED B** - This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**RALLY EXCELLENT A** - This class shall be for dogs that have earned the R.A. title, but have not earned the R.E. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

**RALLY EXCELLENT B** - This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

**CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS**

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall be included in the calculation for championship points. Further Section 15.1.12{C} has been added and states the dog must: "have earned at least one 2-point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed below.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show.
